Declarations of Interest (Written)

MAIN BUSINESS

1. Approval of Minutes: Source Protection Authority Meeting, April 8, 2024

- J. Mason commented that the December 11, 2023 minutes were not attached to the April 8, 2024 agenda and still require approval. The meeting minutes from December 11, 2023 will be attached to the next Source Protection Authority agenda for approval.
- R. Kidd asked about the strengthening of rules surrounding road salt application and how they are being implemented. M. Livingston explained that road salt application is a significant threat to drinking water for municipalities that have vulnerable areas that bisect municipal boundaries. 13 municipalities are now required to have salt management plans, previously only 4 were required. Once the *Source Protection Plan* is revised and approved by the minister, municipalities will have 1 year to establish a salt management plan. Source protection staff will work with municipalities in the establishment of these plans. She added that salt application for industrial, commercial and institutional properties are a threat in certain areas around municipal drinking water areas. Source protection staff will work with businesses individually to ensure risk management plans are in place to mitigate the impacts of salt application on their properties. She highlighted that these changes will come into effect once the *Source Protection Plan* is revised approved by the minister, anticipated for 2025.
- R. Kidd asked if there is a consultation process and if the 13 municipalities were aware of the higher risk to drinking water and who decided that these municipalities were at risk. M. Livingston explained that the technical rules were updated by the province in 2021 and mapping was revised to reflect these changes. Source Protection staff have been coordinating

with the affected municipalities since 2021 to inform municipal staff on the additional policy requirements they are subject to. She noted that affected municipalities were notified in the pre-consultation process (July 2024) as is required under the *Clean Water Act*. Municipal staff were given the opportunity to provide comments and feedback. A second opportunity to provide comments during public consultation is currently open. She noted that municipalities are receptive to the updates. R. Kidd summarized that the province updated the rules which determined the municipalities were at higher risk. M. Livingston confirmed that the province changed the rules in how salt application and storage is determined to be a significant threat. She highlighted that this has increased the amount of significant drinking water threats across the province. Policies must either be developed or changed in response to the updated rules.

Source protection staff reached out to the Executive Director of the Algonquins of Ontario for First Nation for a new representative for the Source Protection committee. The Algonquins of Ontario have selected Sandra Bickell to occupy the First Nation seat on the Source Protection Committee. She reviewed Sandra's qualifications with the committee. She explained that, once approved by both Mississippi Valley and Rideau Source Protection Authorities, Source Protection staff will prepare a letter of appointment and complete orientation with Sandra before the next Source Protection Authority meeting in December.



Recommendation:

That the Mississippi Valley Source Protection Authority receive Section 36 Updates as presented in report 3469/25;

And further resolved, That the Mississippi Valley Source Protection Authority direct staff to submit the Section 36 Update to the Ministry of the Environment, Conservation and Parks.

1.0 Background

On November 14, 2018, our Section 36 Workplan was submitted to Ministry of Environment, Conservation and Parks (MECP) in compliance with the Order dated August 27, 2014 under Section 36 of the *Clean Water Act*. On April 15, 2019, we received an amended Order from the Minister, outlining requirements governing the contents and timeframes of the review and process to be followed for any updates.

This Section 36 Update is an opportunity to update policies that may not be working, consider additional policies, revise our assessment reports to include more recent data and information and realign our documents to correspond with the recently updated Technical Rules.

Our Section 36 Update included minor revisions to certain Source Protection Plan policies, the development of a few new policies and relatively minor updates to the

Assessment Reports, including aligning our documents to consider the new Technical Rules, as mentioned above.

2.0 Consultation Summary

As required under the *Clean Water Act* and the Order from the Minister (dated August 27, 2014), we were required to complete a series of consultation steps.

- 1. Early Engagement with MECP staff outlining proposed changes, offering an early preview of the revisions and updates. March 14th, 2024-May 22, 2024.
- Pre-Consultation with Implementing Bodies (Municipalities and various Ministries) and Persons Engaged in Threat Activities. July 18, 2024-September 20, 2024. An opportunity to review the proposed changes and provide comments and feedback.
- 3. Public Consultation started on October 10, 2024, and concluded on November 26, 2024. Broad consultation opportunity, posted in 4 newspapers throughout the Source Protection Region and paid advertisements on social media to expand reach.

At each step in the consultation process, all comments received were reviewed and considered. Revisions were made at the direction of the Mississippi-Rideau Source Protection Committee (SPC). A comprehensive record of consultation has been maintained and was made available to the Source Protection Committee at each meeting.

A final review of proposed updates was completed by the Mississippi-Rideau SPC at their latest meeting on December 12, 2024. In accordance with the *Clean Water Act*, the SPC provided staff with direction to consult with the Source Protection Authorities prior to submission to MECP. The Source Protection Authorities will give staff the final direction to submit to MECP.

This report was presented to the Rideau Valley Source Protection Authority on January 23, 2025.

3.0 Next Steps

Following this meeting, staff will submit the final package to MECP for decision.
